

The American Psychological Association (APA) referencing style is often used in some social sciences including Education, Psychology and Sociology. Similarly to the Harvard Referencing Style it uses an author /date format when citing. Full details of sources used and cited during your research should be provided alphabetically in an ordered Reference list at the end of your document.

Note: If you are asked to use APA style for referencing purposes, please follow your department's specific recommendations.

Citing one author or more than one author:

When citing one author, the surname of the author and the year of publication should be put into the text at the point after the citation is made. For two authors use an ampersand (&). For more than two authors, use et al. The citation can be a narrative or parenthetical citation as shown in the example.

Examples:

One Author: e.g. Mankiw (1998)

Two Authors: (Hill & Jones, 2007)

• Three Authors: Tiernan et al. (2006)

• Six or more Authors: (Massart et al., 1990)

Reference List

Chapter in a book (where a book has chapters written by different authors)

For chapter title use capitals for the first word of the title and subtitle and any proper nouns. Use (p.), for a single page and (pp.), for multiple pages.

- Format: Author Surname, Initial. (Year). Title of Chapter. In Author's/Editor's Initial. Surname, Title of book [in italics] (Edition.). (p.). Publisher.
- Example: Laffan, B. (1999). The European Union and Ireland. In N. Colins (Ed.), Political issues in Ireland today (p. 36), Manchester University Press.

For an editor use (Ed.)

Book

For books italicize the title. For author, provide surname and initial. Only include edition if it is not the first edition eg. (5th ed.). There is no full stop after the title when there is an edition.

- Format: Author Surname, Initials. (Year of Publication). Title. [in italics] (Edition.). Publisher
- Example: Mankiw, N.G. (1998). *Principles of economics.* Dryden Press.



Edited Book

For an edited book, place the editor in the Author spot and put in the abbreviation (Ed.) or (Eds.) after the last editor.

Example: Massart, D.L., Brereton, R.G., Dessy, R.E., Hopke, P.K., Spiegelman, C.H. & Wegscheider, W. (Eds.), (1990), Chemometrics tutorials, Elsevier Science Publishers.

eBook

- Format: Author/Editor Surname, Initial. (Year). Title [in italics]. (Edition.). Publisher. DOI (if available)
- Example: Sargeant, M. (Ed.) (2011). Age discrimination and diversity: Multiple discrimination from an age perspective. Cambridge University Press. DOI

Electronic Journal article

- Format: Author Surname, Initial. (Year). Title of article. Journal title, [in italics] volume [In Italics] (issue), pages. DOI or URL (if available)
- Example: Power, A. & Kenny, K. (2011). When care is left to roam: Carers experience of grassroots nonprofit services in Ireland. Health and place, 17(2), 422-429.

Web Page

- Format: Author Surname, Initial. (Year of publication or last date updated). Title. [In italics] Name of Website [if different from author] DOI or URL
- Example: Health and Safety Authority. (2016). Health and Safety Authority. http://www.hsa.ie/eng/

Audio Visual Material including works of art, paintings and photographic prints.

- Format: Director Surname, Initial. (Director). (Year). Title[In italics] [Medium]. Distributor/Publisher.
- Example: Guggenheim, D. (Director). (2006). An inconvenient truth: The crisis of global warming [Film]. Paramount.
- Format: Artist or group (Year). Title of song.[Description] On Title of album [In Italics]. Label.
- Example: Keane. (2008). Spiralling [song]. On Perfect Symmetry. Universal Island Records Ltd.
- Format: Artist Surname, Initial. (Year). Title of work [In Italics] [Medium]. Location.
- Example: le Brocquy, L. (1994). *Image of W.B. Yeats* [Painting]. Crawford Art Gallery, Cork.



GenAl text Reference list entry

- Author. (Year). Name of model (version) [Large language model]. URL
- OpenAl. (2025). ChatGPT (version 3.5) [Large language model]. https://chat.openai.com/chat

The author is the company that developed the model

Year is the year the content was created

The name of the model is ChatGPT

Version is the version you have used

[Large language model] Description of the model you use

Give the url of the information

GenAl Image Reference list entry

- Author. (Year). Name of model (version) [Graphic design model]. URL
- Canva. (2025). (Canva free version) [Graphic design model].

Do not repeat publisher if author and publisher are the same.
