## 1. Purpose

This policy is intended to ensure safety of children visiting Libraries of the Munster Technological University and that students and staff are able to study in a quiet environment without disturbance and follows the Universities child protection guidelines.

MTU works with children from time to time in a number of areas including at its constituent colleges, MTU Cork School of Music ('CSM'), MTU Crawford College of Art & Design ('CCAD') & other areas such as summer study courses and across a range of arts and sports activities.

### **MTU Children in the Library Policy Objectives**

MTU is committed to creating a safe and healthy environment for the children with whom it works with or accompanying students and staff and is committed to ensuring their safety and welfare at all times while maintaining an environment conducive to work, research and study.

## 2. Scope

This document refers to safety of children in in all libraries on MTU Cork & Kerry campuses.

## 3. Definitions

This policy regards any individual under the age of of sixteen as a 'child'.

For the purpose of this policy, MTU Libraries means any library located on the Cork or Kerry campuses, including NMCI Library, CSM Library or CCAD Library.

## 4. Roles and Responsibilities

MTU Library Staff have overall responsibility for implementation of the Children in the Library policy and will play a pivotal role in monitoring and reviewing all aspects of the policy.

## 5. Policy

MTU recognises that it is good practice to have a child protection policy to help achieve its aims in this regard. Accordingly, the University produced is based on CIT and ITTs previous policies and is based on the "*Children First, National Guidelines for the Protection and*

*Welfare of Children” and “Our Duty to Care –The Principles of Good Practice for the Protection of Children and Young People”*

The safety of children is paramount to Library staff and a number of restrictions are in place to ensure the safety of children as follows:

- a) Children under the age of sixteen must be accompanied by a responsible adult at all times, in all MTU Libraries, for limited period of time while library users:
  - return material, collect a reserved item.
  - retrieve a book from the shelves.
  - avail of the photocopying services.
  - seek advice at the Library's Information Desk.
- b) Children will be allowed access to MTU CSM Fleischmann Library to borrow material and use library photocopiers. However, children that wish to use the Fleischmann library for an extended period of time must be accompanied by a responsible adult.
- c) Access to certain areas within the library may be off-limits to children under the age of sixteen for health and safety reasons.
- d) Children cannot use Library PC's or access Wi-Fi.
- e) Adult supervisors are expected to care for, supervise and ensure that the behaviour of children in the library is appropriate.
- f) Study spaces may not be used when visiting in the majority of MTU Libraries. Please refer to MTU CSM for arrangements in the Fleischmann library.

## 6. Compliance

Parents/Guardians of unsupervised children may have their library privileges withdrawn.
